WELCOME VENDORS

Thank you for joining the **Stanwood Holiday Fair**—a cheerful indoor gathering celebrating local makers, farmers, and artisans! This one-day event is brought to you by the Stanwood Farmers Market, offering a cozy, festive space to share your products and connect with the community.

We appreciate your professionalism, positive spirit, and teamwork in helping create a fun and memorable event for all.

EVENT BASICS

- **Location:** Indoors at Box of Good Warehouse at 8504 Cedarhome Dr., Stanwood no canopies, tents, or weights are required.
- Set-Up: Begins at 7:30 AM. Please be fully set up and ready to transact by 9:45 AM.
- Event Hours: 10:00 AM-4:00 PM.
- **Tear-Down:** Begins promptly after closing; please do not pack up early.
- **Booth Spaces:** Assigned by event organizers and must stay within your designated footprint.
- **Electricity:** Limited access; requests must be approved in advance.

FEES & PAYMENT

Booth fees are due by **October 31st. Space is limited and not guaranteed until payment is received.** Payments are non-refundable except in the rare event of cancellation by the Market.

WHAT TO BRING

- Tables and display materials (none provided).
- Holiday-themed décor is encouraged!
- Extension cords (if approved for electricity).
- Professional signage and price tags.
- 1-3 items to be included in a raffle drawing throughout the day (optional, but highly encouraged)

WHAT NOT TO BRING

- Anything that will exceed the approved footprint of your designated space.
- Music. (Live music will be performed throughout the event)
- Open flames are not permitted.
- No animals are allowed in the facility.
- Please avoid bringing multiple vehicles if it can be avoided parking is limited and should be prioritized for customers.

RULES OF CONDUCT

- Be courteous, professional, and kind to customers, organizers and fellow vendors.
- Keep your area tidy, safe, and free of hazards.
- No early tear-downs, smoking, or unapproved alcohol on premises.
- Only approved products may be sold; no resale of outside goods unless previously authorized.
- Vendors must comply with all applicable health, food safety, and licensing requirements.

PRODUCTS & COMPLIANCE

Food vendors must meet all **Snohomish County Health Department** standards. All other vendors should ensure their products are safe, legal, and locally made and curated with care.

PARKING & LOADING

- Unload quickly and move vehicles to the designated vendor parking area.
- Please leave front parking spaces for customers.

WEATHER & CANCELLATION

This is an **indoor event**, so weather is not expected to affect participation. If unforeseen circumstances require event cancellation, booth fees will be refunded. Fees are non-refundable for any reason other than event cancellation by the Event Planners.
